### MSSP Skilled Nursing Facility (SNF) 3-Day Waiver Affiliates

Your Medicare benefits do not change when using the ACO SNF 3-Day Rule Waiver. You have the option to choose any provider and the final choice is yours. The ACO SNF 3-Day Rule Waiver waives the requirement for a 3-day inpatient stay prior to Medicare-covered, post hospital, extended-care service for eligible beneficiaries if certain conditions are met. This allows Providers to directly admit to a SNF from multiple sites of care.
